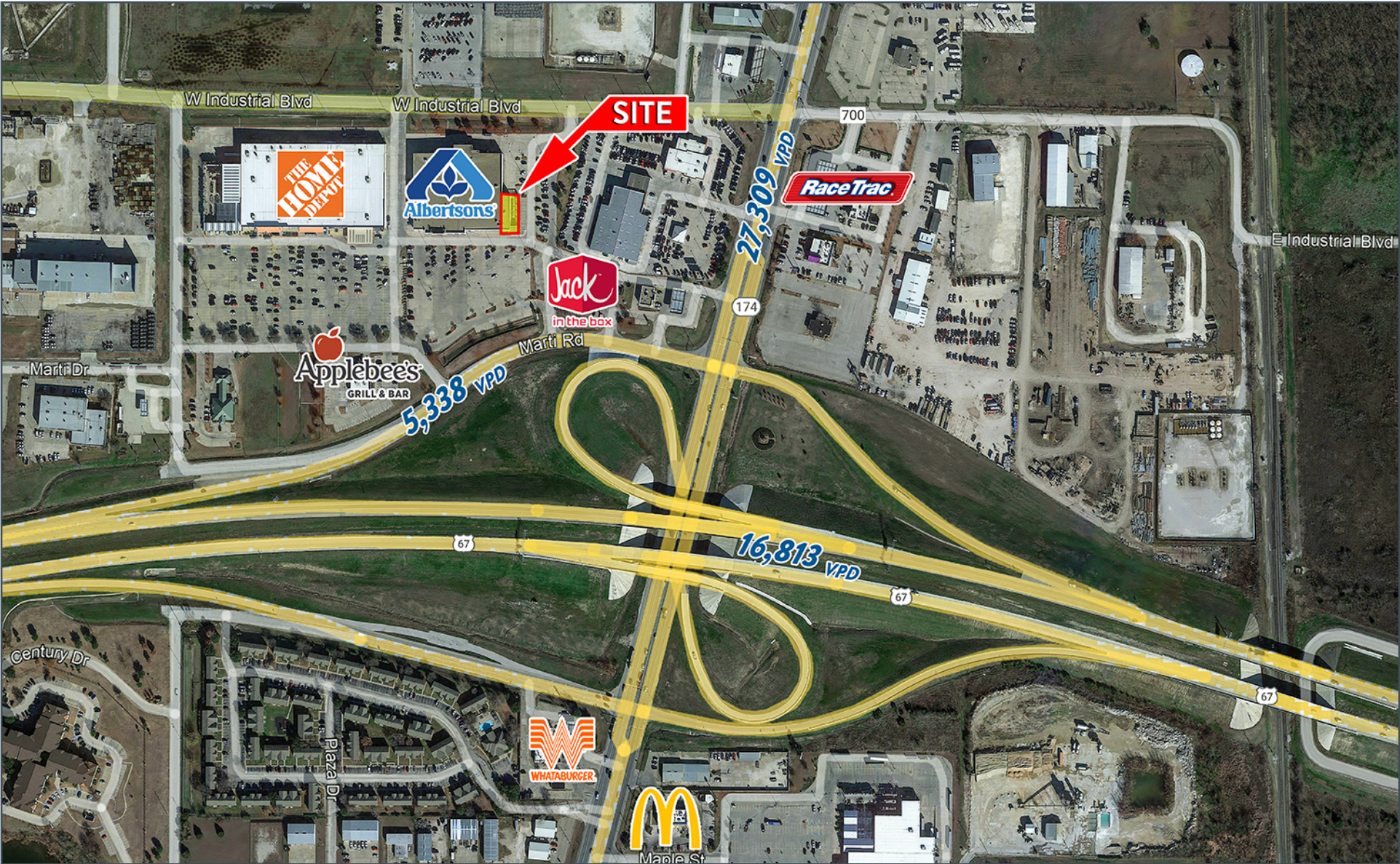


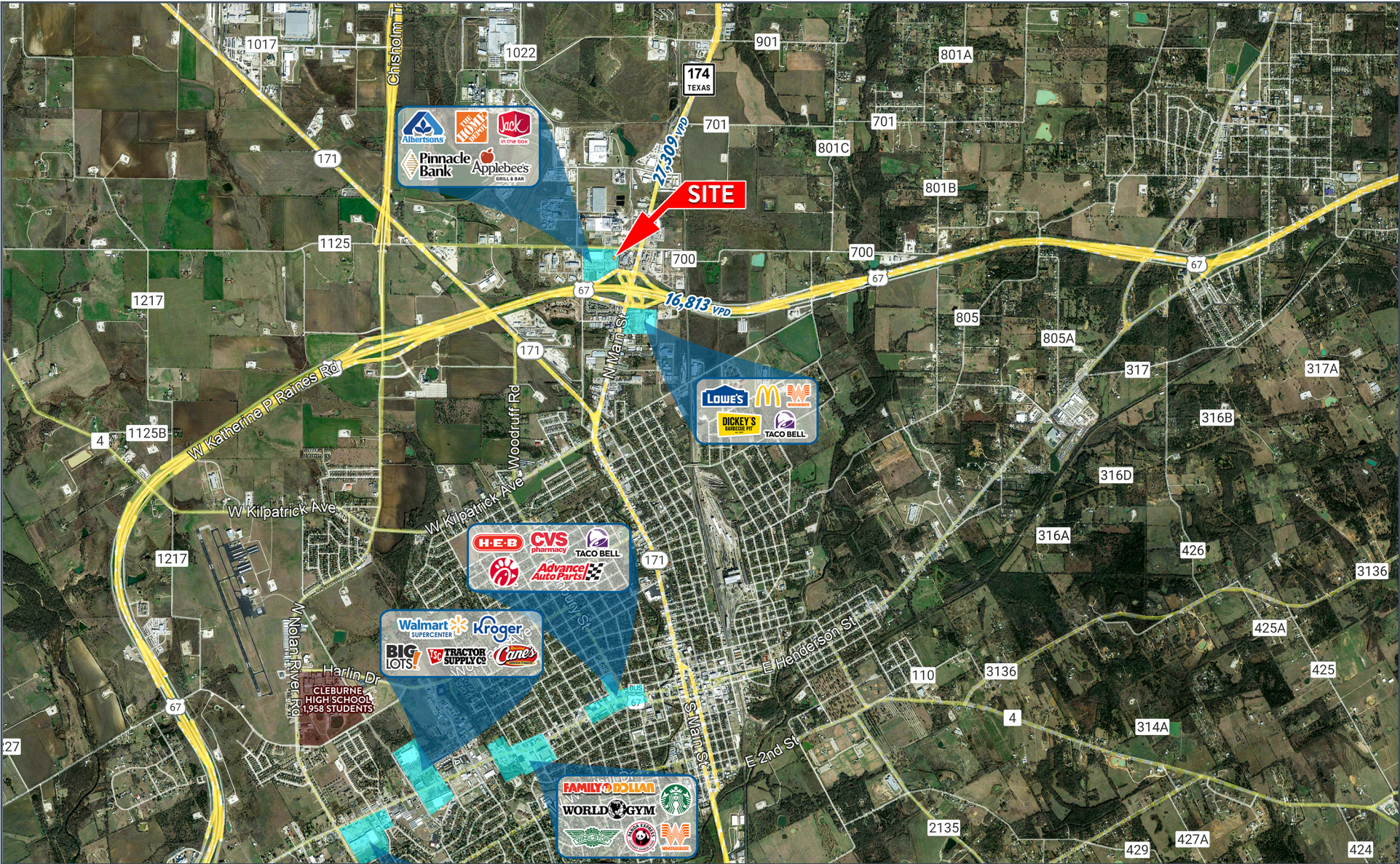


01 SEASONAL FLOOR AREAS
